1. All prices hold if measured work on completion is not less than 90% of each item of the quotation.
2. Where a Variation Price Clause is applicable, all prices are subject to increases in labour rate, transport and all materials.
3. We reverse the right to deliver on to site at any time after the acceptance of a Fixed Price Contract, any materials that we may consider are likely to increase in price, and to receive within 28days, 90% or our invoice value.
4. Unless otherwise stated it has been assumed that all excavations are in normal soil or clay free from chalk, gravel, rocks, roots and footing, etc. Removal of obstructions will be charged extra.
5. Unless otherwise stated it has been assumed that access can be gained to both sides of the fence line, and that a hard road is within reasonable distance from any one part of the line.
6. The fencing will be erected to follow a line clearly indicated by the Purchaser, and will follow approximately the profile of the ground.
7. Unless otherwise indicated, the method of measurements will be in accordance with S.M.M latest editions.
8. We are to supply concrete for embedding posts where specification requires concrete.
9. Please note that this site has not been visited and our rates are subject to confirmation pending site visit.
10. This site had been visited and our rates allow for all hard digging and site peculiarities as a t time of visit.
11. Bent overarms will face inwards towards your property unless otherwise stated on your order.
12. Gate sockets will be fixed providing ground conditions permit, otherwise sockets will be provided for you to fix when ground has been made to correct level.
13. Please note our quotation allows for the fencing to be carried out at one site visit and would point out that if the contract is stopped by yourselves and same proves necessary for us to leave the site a standard charge of £1000.00 will apply for each occurrence.
14. Rates will remain firm for a period of 2 months from the date of this quotation, except for fluctuations under or by virtue of any Government Legislation unforeseen and/or not fixed at the date of tender.
